TERMS AND CONDITIONS FOR KONNECT MOBILE TOP-UP CAMPAIGN (THE "CAMPAIGN")

1. These Terms and Conditions (the "Terms and Conditions" or "T&Cs") shall apply to those customers who participate in the Campaign as per the campaign mechanics and who conduct the Transaction (defined below). These T&Cs constitute an agreement between you ("You" or the "Customer") and Habib Bank Limited ("HBL") when You perform the Transaction, whereby You accept and agree to be bound by these Terms and Conditions.
2. Top 100 Customers with most number of eligible Transactions executed during the campaign dates will receive PKR 2,300 cashback upon conducting a transaction of minimum PKR 200/- through Konnect Mobile Application subject to Clause 7 below (the "Transaction").
3. The minimum amount of Transaction to be eligible for the Campaign is PKR. 200/-
4. The Customer is eligible for cashback reward only once during the Campaign Period. The greater the number of Transactions means more chances to win.
5. The cashback reward shall only be applicable on Transactions conducted by Customers through Konnect by HBL Mobile Application.
6. The cashback reward will be disbursed to the Customer in his/her account 14 days after the end of the Campaign.
7. All Transactions via Konnect Application are eligible for the draw except cash in, cash out & all types of funds transfers.
8. HBL may use multiple modes of communication for the Campaign, including but not limited to social media, applications, agent location, SMS, etc.
9. Only those Customers will qualify for the Campaign who performed the Transaction as per the Campaign offers announced.
10. If the Customer's account with HBL has been closed, blocked, blacklisted (or either), that Customer shall be immediately disqualified.

HBL reserves the right to discontinue the Campaign at any time and may at any time revise these Terms and Conditions for any reason whatsoever by updating HBL's website i.e. <https://www.hbl.com/> and the Konnect webpage i.e. <https://www.hbl.com/personal/konnect>. The Customers shall be bound by any such revisions and the Customer will be notified but should also periodically visit HBL's website and the Konnect webpage to review the current Terms and Conditions.
12. The Campaign will be applicable to only those eligible Customers utilizing Branchless Banking – Konnect By HBL Mobile Application.
13. The Campaign is applicable to Customers residing in Pakistan only.
14. This Campaign is valid from 21st March, 2022 till 31 March, 2022, (the "Campaign Period").
15. Customers may receive SMS from Konnect by HBL (Branchless Banking) short code 8425 and HBL short code 4250.
16. Customers must not share any PIN code, passcode, passwords, etc. associated with their accounts with anyone.
17. By accepting these Terms and Conditions, the Customer also agrees to HBL's right as the final decision-making authority in all decisions regarding the processing of the Transaction.

18. These Terms and Conditions shall be governed by the laws of the Islamic Republic of Pakistan.
