		Important Notes:	
		a) For Islamic Prestige Clients, charges for Islamic Prestige Semi-Digital Lockers, Automated Lockers and Regular Lockers will be applicable as per I-SOBC.	
		b) The Islamic Prestige Lockers (Semi Digital and Automated) facility is available only for HBL Islamic Prestige clients, maintaining deposit relationships (CASA and TD) as per the abovementioned criteria.	
		c) The AUM-based (Islamic Mutual Funds, BancaTakaful, Islamic House Finance, Islamic Car Finance) clients can only access the regular lockers, subject to the availability and prevailing charges.	
		d) Quarterly membership retention fees will be recovered against Semi-Digital and Automated Lockers categories, in case balances fall below the aforementioned defined criteria.	
		e) Key Deposit Fee will be applied at the time of new locker issuance and will be refunded at the time of locker surrender.	
		<u>Note:</u> In case a locker is broken open for non-payment of fee and its content are retained with inventory in a separate locker, whenever the locker holder(s) visits the Bank for collection of the items, all outstanding fees (With due charity) and break-opening charges should be recovered before the contents are delivered.

The following clarification regarding the Account Maintenance Charges under Part V – HBL Islamic Prestige is also being added.

		* The fee will be applicable in case of non-maintenance of the required average balance (qualification criteria mentioned above).	
		In case, the balance is not maintained under the prestige qualifying criteria (defined above), the accounts shall be downgraded, and the membership fee will be levied every quarter (as per I-SOBC) to active World Elite Debit Card(s) holders and customer(s). However, they will be allowed to use World Elite Debit Card till the card(s) expiry.
