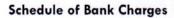

- Fees may be waived on PO for a minimum of 10 PO per month.
- Credit Processing Fees & Charges shall be as per terms of approval.
- The Schedule of Charges is applicable for the usual transactions. Stamps duty, correspondent charges and other out of pocket expenses, if any, may be added. The Bank reserves the right to impose charges on transactions which are not covered in this schedule of charges and to amend any of the terms herein without prior notice.
- VAT is applicable at applicable rate on all fees/charges and commission effective from 1st July 2002 as per Govt. circular no. SRO 117- LAW2002/342 - VAT dated 6 June 2002 except in cases waived by NBR.
- As per NBR's circular -5(5) Mushok-Basto: Sheba o Abo:/07 (Ongsho 1) dated 04 April 2011, Excise Duty will be separately applicable on customers' all accounts (savings, current, loan or other accounts) held with the bank.
