#### **TERMS AND CONDITIONS FOR BOOKME CAMPAIGN**

1. These Terms and Conditions (the “**Terms and Conditions**” or “**T&Cs**”) shall apply to those customers who perform as per the campaign mechanics through HBL Mobile Application and /or Konnect Mobile Applications (the “**Transaction**”). These T&Cs constitute an agreement between you (“**You**” or the “**Customer**”) and Habib Bank Limited (“**HBL**”) when You perform the Transaction, whereby You unconditionally accept and agree to be bound by these Terms and Conditions.
2. Under the campaign, Customers will be given a discount of Flat 20% capped at PKR 2000 per passenger on a domestic flight booking purchased through Bookme Air Tickets widget via Konnect Mobile Application and/or HBL Mobile Application.
3. All Customers who perform a Transaction shall be eligible for a flat 20% discount capped at PKR 2000 on one ticket. (Discount)
4. This offer can be availed by one Customer against one ticket at a time.
5. In case of a round trip or multi city booking the voucher will be applied only once on the entire trip and not individually for every flight chosen.
6. This is a limited time offer and shall expire upon exhaustion of allocated budget.
7. This offer is not available to travel agents.
8. Bookme reserves the right to cancel any booking where it deems that a discount has been used multiple times fraudulently.
9. Bookme will deduct the discount amount in cases of cancellations and refunds.
10. In the event of rescheduling, the Customer shall bear the price difference (base fare, taxes, surcharge, and other applicable fees).
11. HBL and Bookme reserve the mutual right to cancel, alter, modify, or replace this offer at any time without any prior notice.

12. HBL can use any mode of communications for the campaign, including but not limited to, social media, applications, agent location, SMS, etc.
13. Only those Customers will qualify for the discount under the campaign who perform the Transaction as per the campaign offer announced.
14. If the Customer's account with HBL has been closed, blocked, blacklisted (or either), that Customer shall be immediately disqualified from availing the discount under the campaign.
15. HBL reserve the right to discontinue the campaign at any time and may at any time revise these Terms and Conditions for any reason whatsoever by updating HBL's website and the Konnect website. The Customers shall be bound by any such revisions and should therefore periodically visit HBL's website and the Konnect website to review the current Terms and Conditions.

17. The Campaign is applicable to Customers residing in Pakistan only.

19. Customers must not share any PIN code, passcode, passwords, etc. associated with their accounts with anyone.
20. By accepting these Terms and Conditions, the Customer also agree to HBL's right as the final decision-making authority in all decisions regarding the processing of the Transaction.
21. These Terms and Conditions shall be governed by the laws of the Islamic Republic of Pakistan.
